- Electric element cooking must be UL approved.
- Tables and chairs will NOT be provided, please bring your own.
- Limited electric hookups will be provided; however, bring your own drop cords.
- Food vendors should have their own power due to limited electrical hookups.
- Each trader/vendor is required to leave their space clean and free of all trash and debris. There is a dumpster at the site for your convenience.
- Be up to date with all health department requirements.
- Applicants are approved on a first-come, first-served basis. Please send completed applications with fee ASAP as spaces fill up quickly.

Food Booth Rental

Includes three (3) passes per vendor are allowed. Any additional passes will need to be purchased for \$12/person, which will cover all three days (\$8/person per day otherwise).

- Applications received and PAID *on or before* August 24, 2019.
 - Friday **OR** Sunday - September 6 or 8, 2019.....\$100.00
 - Saturday, September 7, 2018.....\$125.00
 - **Weekend Pass - Sept. 6-8, 2019.....\$300.00**

Trader Booth Rental

Includes two (2) passes per vendor are allowed.

- Applications received and PAID *on or before* August 24, 2019.
 - Friday, Saturday, **OR** Sunday – Sept. 6-8, 2019.....\$75.00 per day
 - **Weekend pass – Sept. 6-8, 2019 \$150.00**
